Investment Rationale and Objectives

OCP Credit Strategy Fund provides Unitholders with exposure to an actively managed, unlevered, diversified portfolio comprised primarily of senior debt obligations of non-investment grade North American issuers.

The Fund's objectives are: (i) to maximize total returns for Unitholders (ii) to provide Unitholders with attractive, quarterly distributions, currently targeted to be \$0.70 per annum, representing an annual yield of 7% based on the original issue price of \$10.00 per Unit; and (iii) to preserve capital.

Commentary

Net performance of OCP Credit Strategy Fund (the Fund) was 1.92% and 5.34% for July and year-to-date, respectively. The Credit Suisse Leveraged Loan, Credit Suisse High-Yield and S&P 500 TR indexes returned 1.41%, 2.45% and 3.69%, and 5.69%, 11.98% and 7.66% during July and year-to-date, respectively.

Strong positive performance during the month was a reflection of continued positive market sentiment, as well as strong performance in several of the Fund's larger positions, most notably PRISA. In July, the majority of the Fund's positions were positive contributors, with a limited number of negative positions.

The Fund has an investment in various tranches of the capital structure of PRISA, the world's leading Spanish and Portuguese-language media group. PRISA traded down over Brexit concerns and the potential impact on its businesses. As market fears abated, the Fund's investment in PRISA recovered as well.
